Medical Facilities for Research Scholars in HBCSE

The following arrangements have been made by the institute for providing medical facilities to its research scholars:

1. A memorandum of agreement has been signed with Surana Sethia Hospital and Research Centre, Chembur, Mumbai for providing inpatient and outpatient cashless hospitalization treatment for research scholars.
2. In case of a medical emergency during office hours, research scholars can go to Surana Sethia Hospital and Research Centre, Chembur, taking a credit letter from one of the following authorized signatories:
 - Dr. Mashood K.K.
 - Dr. Aswathy Raveendran
 - Mr. J. B. Waghmare

Research scholars will need to carry their valid HBCSE identity card and credit note for admission in Surana Sethia Hospital and Research Centre, Chembur.

3. In an emergency situation after office hours or during holidays, research scholars may get admitted to Surana Sethia Hospital and Research Centre, Chembur on the basis of his / her valid HBCSE identity card and a telephonic approval by one of the above mentioned authorized signatories. The credit letter is to be submitted to Surana Sethia Hospital and Research Centre, Chembur, Mumbai on the next working day.
4. Surana Sethia Hospital and Research Centre, Chembur will not ask for any security deposit at the time of admission.
5. Research scholars are entitled for Economy or Twin Sharing with food. **Any Demand for higher class above the entitlement will not be under the scope of HBCSE. The difference amount will be settled by the patient at the time of discharge.** In case a bed is not available in the hospital in the class entitled to the research scholar, the patient will be admitted in one of the other classes and the change in class will be intimated to HBCSE by Surana Sethia Hospital and Research Centre, Chembur.
6. At the time of discharge, the patient is not required to pay any hospitalization fees. The patient will be required to sign on the reverse of the bill at the time of discharge.
7. The hospital will keep the patient only for the required number of days of treatment, and carry out only the required investigation and treatment, for the ailment for which he or she is admitted. Any other incidental investigation required by the patient for his or her benefit are not payable under the scheme, and the research scholar will have to bear the cost of the same.
