- 1. The above fellowships are applicable only to research scholars paid from DAE funds.
- 2. A student having higher qualification, who competes with students having lower qualification at admission, will be paid the fellowship at the rate applicable to the latter.
- 3. For Integrated MSc-PhD programme, Graduate Degree in Basic Science or Graduate Degree in Professional Course is to be treated as equivalent, if selected by same admission process. Starting fellowship to be ₹ 16,000 pm and book grant ₹ 20,000 pa, as per DAE OM-6075 dated 8-May-2015.
- 4. For PhD programme, Postgraduate Degree in Basic Science or Graduate Degree in Professional Course is to be treated as equivalent, if selected by same admission process. Starting fellowship to be ₹25,000 pm and contingency ₹32,000 pa, as per DAE OM-3943 dated 24-March-2015.
- 5. For PhD programme (PPG-PhD), Postgraduate Degree in Professional Course is to be treated differently, if selected by a higher level admission process. Starting fellowship to be ₹28,000 pm and contingency ₹32,000 pa, as per DAE OM-3943 dated 24-March-2015.
- 6. For the following categories the changes are to be implemented from the start of academic year 1-Aug-2015.
  - 1<sup>st</sup> year Integrated PhD students
  - Integrated PhD students after 6years
  - PhD students after 5 years

Fellowships for the above categories shall continue at existing levels, at this stage.

- 2. A student having higher qualification, who competes with students having lower qualification at admission, will be paid the fellowship at the rate applicable to the latter.
- 3. For JRF, Postgraduate Degree in Basic Science or Graduate Degree in Professional Course is to be treated as equivalent. Starting fellowship to be ₹ 25,000 pm and no contingency, as per DAE OM-3944 dated 24-March-2015.

- 4. For SRF, Postgraduate Degree in Professional Course or after 2 years as JRF is to be treated as equivalent. Starting fellowship to be ₹ 28,000 pm and no contingency, as per DAE OM-3944 dated 24-March-2015.
- 5. For the above categories the changes are to be implemented from the 1-Oct-2014.
